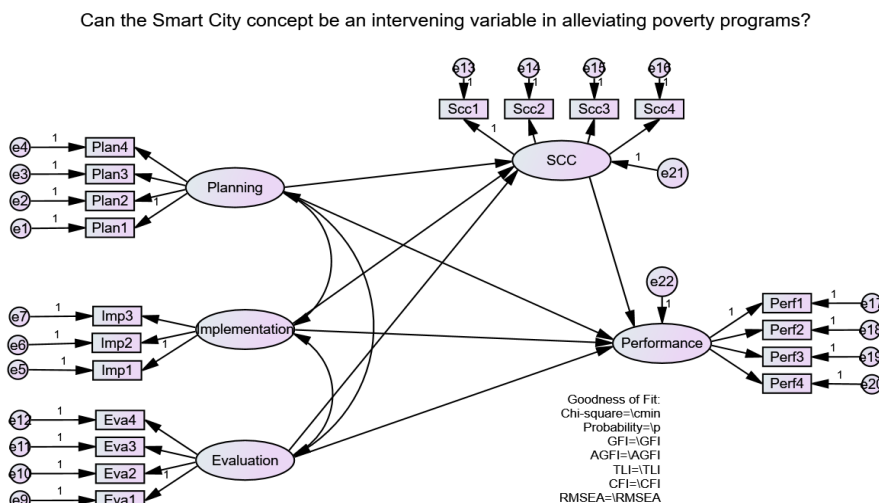

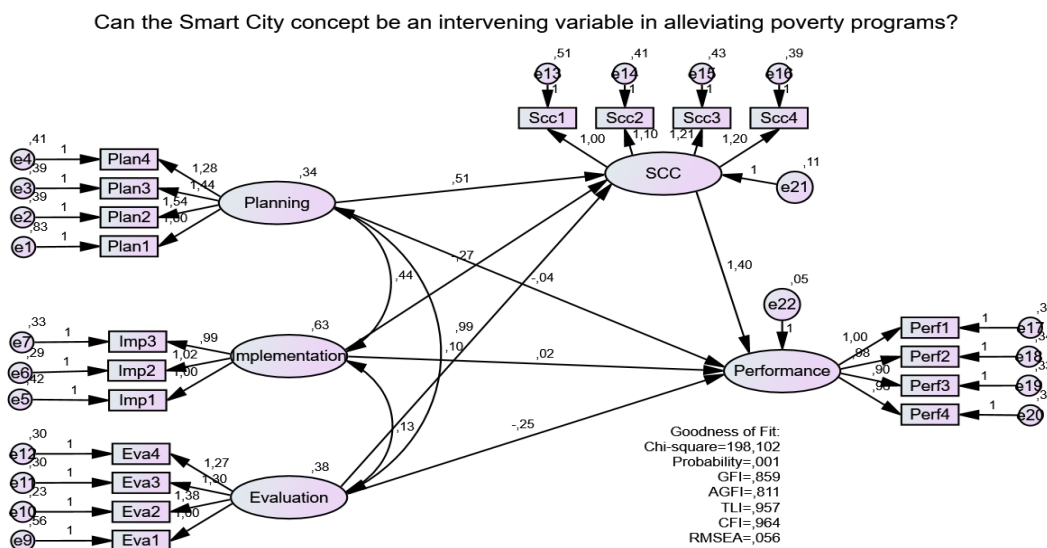


Figure-2: Result of SEM AMOS
